

ORDINANCE D-2422-18

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF CARMEL, INDIANA,
AMENDING CHAPTER 3, ARTICLE 2, SECTION 3-58 OF THE CARMEL CITY CODE**

Synopsis: Adds violations of the golf cart ordinance to the City's Ordinance Violations Bureau.

WHEREAS, the City has established an Ordinance Violations Bureau and appointed an Ordinance Violations Clerk pursuant to IC 33-36-2-1; and

WHEREAS, pursuant to Carmel Ordinance D-2304-16, violations of the City's golf cart ordinance are to be processed and paid to the Carmel Ordinance Violations Bureau;

WHEREAS, it is in the best interests of the citizens of Carmel to bring violations associated with the City's golf cart ordinance within the jurisdiction of the Ordinance Violations Bureau.

NOW, THEREFORE, IT IS AGREED AND ORDAINED, by the Common Council of the City of Carmel, Indiana, as follows:

Section 1. The foregoing Recitals are incorporated herein by this reference.

Section 2. Section 3-58(c) of the Carmel City Code is hereby amended and shall read as follows:

(4) All golf cart ordinance violations described in § 8-43 are subject to the schedule of fines contained in § 8-43(g)

Section 5. All other current provisions of City Code Section 3-58 shall remain in full force and effect and are not affected by this Ordinance.

Section 6. All prior ordinances or parts thereof inconsistent with any provision of this Ordinance are hereby repealed, to the extent of such inconsistency only, as of the effective date of this Ordinance. However, the repeal or amendment by this Ordinance of any other ordinance does not affect any rights or liabilities accrued, penalties incurred or proceedings begun prior to the effective date of this Ordinance. Those rights, liabilities and proceedings are continued and penalties shall be imposed and enforced under such repealed or amended ordinance as if this Ordinance had not been adopted.

Section 7. If any portion of this Ordinance is for any reason declared to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portions of this Ordinance so long as enforcement of same can be given the same effect.

Section 8. This Ordinance shall be in full force and effect from and after its passage and signing by the Mayor.
