1. OLD BUSINESS

- a. **Tenth Reading of Ordinance D-2488-19**; An Ordinance of the Common Council of the City of Carmel, Indiana, Amending Chapter 8, Article 6, Sections 8-56(d) and 8-58(a); Sponsor(s): Councilor(s) Finkam and Worrell. **REMAINS IN THE FINANCE, UTILITIES AND RULES COMMITTEE.**

Synopsis:

Ordinance adds vehicle weight restrictions to various City streets.

- b. **Third Reading of Ordinance D-2511-20**; An Ordinance of the Common Council of the City of Carmel, Indiana, Amending Chapter 6, Article 5, Division III, Section 6-99 and Adding Chapter 6, Article 5, Division III, Section 6-102 to the Carmel City Code; Sponsor(s): Councilor(s) Aasen, Campbell, Kimball, Nelson, Finkam, Rider and Worrell. **ADOPTED AS AMENDED**

Synopsis:

This ordinance updates and strengthens the welfare protections provided to animals within the City's corporate limits and regulates commercial animal establishments.

- c. **Second Reading of Ordinance D-2512-20**; An Ordinance of the Common Council of the City of Carmel, Indiana, Authorizing the Acquisition, Construction and Installation of Certain Improvements for the Sewage Works System of the City of Carmel, Indiana, the Issuance of Revenue Bonds to Provide the Cost Thereof, the Collection, Segregation and Distribution of the Revenues of Such System, the Safeguarding of the Interests of the Owners of Such Revenue Bonds and Other Matters Connected Therewith, Including the Issuance of Notes in Anticipation of Such Bonds, and Repealing Ordinances Inconsistent Herewith ; Sponsor(s): Councilor(s) Finkam and Worrell. **ADOPTED**

Synopsis:

Bond Ordinance authorizing the issuance of revenue bonds payable from the net revenues of the City's sewage works utility to finance various wastewater improvements in the City.

- a. **First Reading of Ordinance D-2513-20**; An Ordinance of the Common Council of the City of Carmel, Indiana, Amending Chapter 4, Article 5, Section 4-98 of the Carmel City Code; Sponsor: Councilor Finkam. **TABLED**

Synopsis:

This ordinance codifies the process of applying for economic development incentives from the City of Carmel.

- b. **First Reading of Ordinance D-2514-20**; An Ordinance of the Common Council of the City of Carmel, Indiana, Amending City Code Chapter 8, Article 3, Section 8-26(a) Designating Worksite Speed Limits on Certain City Streets; Sponsor(s): Councilor(s) Aasen, Kimball and Worrell. **ADOPTED**

Synopsis:

Extends the worksite speed limit of 40 m.p.h. on Keystone Parkway until December 1, 2020.

- c. **First Reading of Ordinance D-2515-20**; An Ordinance of the Common Council of the City of Carmel, Indiana, Amending Chapter 3, Article 1, Division 2, Section 3-33(a) of the Carmel City Code; Sponsor: Councilor Finkam. **ADOPTED**

Synopsis:

Ordinance clarifies the procedure used to introduce ordinances at Carmel Common Council meetings.

4. **AGENDA ADD-ON ITEMS**

- a. **First Reading of Ordinance D-2516-20**; An Ordinance of the Common Council of the City of Carmel, Indiana, Adding Chapter 2, Article 3, Section 2-59 and Chapter 2, Article 3, Section 2-86 to the Carmel City Code; Sponsor(s): Councilor(s) Campbell, Finkam and Worrell. **ADOPTED**

Synopsis:

This ordinance is designed to facilitate the ability of the City's civilian employees to manage their work and family obligations should they be affected by the coronavirus and to help ensure that City services are not disrupted and the City's interests are protected.
