12. **OLD BUSINESS**

- a. **Eighth Reading of Ordinance D-2563-20**; An Ordinance of the Common Council of the City of Carmel, Indiana, Authorizing the Issuance of the Local Income Tax (LIT) General Obligation Bonds for the Purpose of Providing Funds to Pay for Certain Property Acquisition and Capital Improvement Projects in the City; Sponsor(s): Councilor(s) Kimball, Rider and Worrell. **Remains in the Finance, Utilities and Rules Committee**

Synopsis:

This ordinance authorizes bonds in an amount not to exceed \$8,000,000 to finance the completion of the Police Headquarters expansion project, if necessary, and to fund other redevelopment and economic development projects in the City. The bonds will be payable from a pledge of the City’s local income tax (LIT) distributions with a back-up pledge of a general obligation property tax as a credit enhancement.

- b. **Eighth Reading of Ordinance D-2565-20**; An Ordinance of the Common Council of the City of Carmel, Indiana, Amending Chapter 2, Article 4, Section 2-107 of the Carmel City Code; Sponsor(s): Councilor(s) Finkam, Rider, Campbell and Worrell. **Remains in the Finance, Utilities and Rules Committee**

Synopsis:

This Ordinance requires the Plan Administrator of the Medical Escrow Fund (Fund 301) to seek Council approval before using excess funds to expand benefits or suspending collection of medical and dental insurance premium payments from the City of Carmel, its employees, or retirees remaining on the City’s medical and dental insurance plan.

- c. **Second Reading of Ordinance D-2579-21**; An Ordinance of the Common Council of the City of Carmel, Indiana, Authorizing the Issuance of Economic Development Tax Increment Revenue Bonds to Support the Signature Project, and Authorizing and Approving Other Actions in Respect Thereto; Sponsor: Councilor Worrell. **Sent to the Finance, Utilities and Rules Committee**

Ordinance authorizes the issuance of developer TIF bonds by the City of Carmel, Indiana, to finance improvements to support The Signature Project.

This resolution approves appropriation of proceeds of sale of existing Police Station Property to Carmel Municipal Facilities Building Corporation

Synopsis:

Appropriates funds in the Non-Reverting Center Green Ice Rink Fund to pay for the construction of the Ice Palace to be located on Carter Green.

This ordinance amends the 2021 salary ordinance by reclassifying the Carmel Police Department's Community Resource Specialist position to that of Community Relations Specialist.

- b. **Resolution CC-05-17-21-02**: A Resolution of the Common Council of the City of Carmel, Approving a Transfer of Funds Between the Grant Fund (#900) and the Motor Vehicle Highway Fund (#201); Sponsor(s): Councilor(s) Aasen, Green and Nelson.

Synopsis:

Transfers \$1,000,000.00 received by the City for the INDOT Community Crossing Grant from the Grant Fund into the Motor Vehicle Highway Fund in order to use the funds for additional street repaving.

- c. **Resolution CC-05-17-21-03**: A Resolution of the Common Council of the City of Carmel, Approving a Transfer of Funds Within the 2021 Carmel Law Department Budget; Sponsor(s): Councilor(s) Rider, Campbell, Aasen and Hannon

Synopsis:

Transfers \$50,000.00 between various line items within the 2021 Carmel Law Department Budget to cover office furniture and other expenses associated with the Law Department's move to new offices in City Hall.
