Course Maintenance

Maintenance of the golf course is the most important aspect of protecting the City asset. Course conditions are also crucial for business operations as customers prefer excellent playing conditions. Proper maintenance also provides customer safety, enhances environmental benefits and reduces cost. Grounds maintenance is the largest portion of this program and consists of fertilizer and pesticide products to produce excellent playing conditions and aesthetic appeal. Fuels for operating equipment and equipment rentals are also included.

Total Cost-\$250,800



Capital Leases

Existing capital lease payments which include cart path installation and GPS for golf carts.

Total Cost-\$222157



Building Maintenance

Repair and maintenance of Clubhouse, maintenance building irrigation pump house and bridges. Includes preventative maintenance agreements, repair parts and services along with general upkeep such as painting.

Total Cost-\$99,000



Utilities

Utilities for operation of clubhouse and golf course. Included are trash collection and cellular phone fees for 1 phone.

Total Cost-\$95,900



Pro Shop/Office

Costs associated with operating the pro shop and administrative portions of the golf course. The largest portion of this program is credit card fees that are paid to processor for each transaction. This does not include sales items, but only the every day operational costs.

Total Cost-\$102,825



Sales Items

Items purchased to be sold in the pro shop and on the golf course. Soft goods include clothing and apparel, hard goods include golf balls, clubs and tees. Margins on these products average 25%.

Total Cost-\$115,000



Education

Items include continuing education for all full-time employees. Conferences, organizational memberships and costs associated with licensing and any travel required to attend meetings. Liquor licensing for employees is included also.

Total Cost-\$17,500



Facility Improvements

Wish list items to improve operational and safety features on the property. Parking lot expansion is needed to accommodate daily operations and special events. Cameras installed inside building and in parking lot to protect City assets and customer vehicles. Shade structures for the patio overlooking the golf course also needed to extend customer usage.

Total Cost-\$59,000
